GENERAL CONDITIONS - Bureau Bosman BV

1. These general conditions apply to and are part of every agreement, every offer and every acceptance of offers, as well as resulting performances by which Bureau Bosman BV acts as direct or indirect organizer and/or proprietor of tradeshows, conferences and events and/or direct or indirect facility service provider and consultant.
2. The applicability of any general conditions from the participant in trade shows, conferences and events and the buyer of facility services and consults of BUREAU BOSMAN B.V. do not apply to the legal relationship between BUREAU BOSMAN B.V. and the participant/buyer and are explicitly refused.
3. Participation in the trade show, conference or event includes the time necessary for construction and dismantling of the booth(s) and/or trade show, event or conference.
4. Participant, respectively, buyer is obliged to participate in the trade show, conference, or event and use the provided facility services during the entire term of the agreement.
5. Payments for participation in the trade show and facility services should take place as follows: For billing of rented booths and/or booth space and facility services, the expiration date as stated on the invoice must be strictly observed. Amounts that are billed within two weeks of the start of the trade show, conference or event must be paid in full on the day the invoice is received. For cash payments an administration fee of € 7, 50 will be charged. In case of late or partial payment of the billed amounts, participant/buyer will owe legal interest of 1% per month over the amount due, where part of a month will be considered a full month.
6. BUREAU BOSMAN BV reserves the right at all times to change scheduled dates of trade shows, conference or events or cancel them. In the unexpected event that BUREAU BOSMAN B.V. exercises that right, the participant/buyer has no right to compliance of the agreement against the originally agreed date nor is the participant/buyer entitled to reimbursement of any damages, regardless what it is named or based upon.
7. Notwithstanding what is stipulated in number 5, if BUREAU BOSMAN B.V. cancels a trade show, conference or event it will refund any invoices paid by the participant/buyer. BUREAU BOSMAN B.V. is explicitly not obliged to refund any amount in case it changes the date of a trade show, event or conference.
8. Cancellation of participation in a trade show and/or purchase of the facility services must be done in writing to BUREAU BOSMAN B.V. stating the reasons. Cancellation is only allowed with the permission of BUREAU BOSMAN B.V. If BUREAU BOSMAN B.V. authorizes the cancellation, which it can never be obliged to do; BUREAU BOSMAN B.V. reserves the right to demand full payment of the invoice.
9. BUREAU BOSMAN BV is authorized, but not obliged, to enter into an agreement with the prospective participant/buyer and is entitled to (legally) exclude persons from participation for its own reasons. In such cases paid invoices will be refunded.
10. BUREAU BOSMAN BV can never be held responsible for any damages, regardless of what they are called or based upon, that are a result of or related to participation in the trade show, conference or event or to the purchase of facility services or consults. These excluded damages include, but not are not limited to, damage to goods or persons, material loss and consequential loss.
11. Every participant/buyer is obliged to insure himself adequately during the period of participation or purchasing and remain insured against the results of legal liability and is liable for all damages of BUREAU BOSMAN B.V. and third parties that are directly or indirectly inflicted by him/her, his/her personnel or any third party that falls under his/her responsibility during the term of participation in the trade show, conference or event or during the time of provision of the facility services. Participant/buyer will, upon first request, protect BUREAU BOSMAN B.V. against all liabilities of third parties and indemnify BUREAU BOSMAN B.V. for all damages and cost by BUREAU BOSMAN B.V.
12. Every participant/buyer is obliged to take adequate measures to prevent that the facility items made available to him, goods that are his property or provided to him in loan are stolen, destroyed, damaged or otherwise affected in value during the trade show, conference or event. The participant/buyer is obliged to insure these goods adequately during the concerned term, as far as the goods are not insured by a third party.
13. This agreement between BUREAU BOSMAN B.V. and participant and buyer is subject to Dutch law. All disputes resulting from this agreement, also those that are considered a dispute by only one of the parties, will be assessed exclusively by the Court of 's -Hertogenbosch.
